
# **Academic Integrity**

According to the Tertiary Education Quality and Standards Agency (TESQA, n.d.):

Acting with "honesty, trust, fairness, respect, and responsibility"

> Acknowledging ALL sources of information used in an assessment (Referencing)

- Using your own words (where possible) Paraphrasing
- Accurately reporting research findings
- Respecting copyright and privacy laws

- **⊗** Copying a quote from the Internet without in-text citation
- Writing the exact words your trainer said in class
- Paraphrasing without in-text citation
- **⊗** Copying another student's work
- **⊗** Using a reference list without in-text citation
- Working on an assessment with a classmate and using the same words in your answers
- **⊗** Copying from the study guide or references provided by SCEI without citing it as your source

# Copying, Cheating & Plagiarising

Plagiarism: "the practice of taking someone else's work or ideas and passing them off as one's own."

- You cannot present another person's work as your own work by copying or reproducing it without acknowledgement of the source (referencing correctly).
- At Southern Cross Education Institute, the accepted style of referencing is APA referencing.
- It is a form of intellectual property theft and unethical

## **Common Issues**

#### Collusion

- Working with other students on a task that is meant to be done individually
- Copying off another student
- Giving answers to other students

#### **Fabricating information**

- Giving false/incorrect info from a source
- Making up data or info without evidence
- Providing an inappropriate source to make false info look credible

# Recycling/resubmitting work – Self-plagiarism

- Submitting parts of or full assignments already submitted by you
- Can happen accidentally (e.g., using similar wording to a previous assignment for reference)

#### Contract cheating

Paying another person to write an assignment for you (ghostwriting)

# **Consequences of Academic Dishonesty**

#### PP42 Plagiarism Policy

- Resubmission of the assessment
- Taking another form of assessment
- Getting a fail grade for the assessment
- Getting a fail grade for the unit of study
- Receiving an academic warning

Resubmission cost of \$200.00 per unit

#### PP96 Academic Misconduct Policy

#### 1. First offence

- Fail grade for the assessment
- Resubmit assessment
- Required to attend referencing assistance class

#### 2. Second offence

- Fail grade for the assessment
- Resubmit assessment
- 60% mark maximum if passed
- Written warning

#### 3. Third offence

- Fail grade for the assessment and unit
- Meeting with Student Welfare and Nursing Coordinator
- Re-enroll into units at own cost

# MAINTAINING ACADEMIC INTEGRITY

# Paraphrasing & Quotes


Paraphrasing = Writing information in your own words (instead of direct quotes)

According to DeLaune et al. (2020), the problem-solving method used to make decisions about patient care is called the nursing process.

Avoid reading the source as you write

If using direct quotes, give the page number (if possible)

"The nursing process is the specific problem-solving method used by you to arrive at the point at which decisions about patient care can be made" (DeLaune et al., 2020, p. 64).



# **Avoiding Plagiarism**

- Paraphrase as much as possible
- Make your list of sources as you're researching/writing, not at the end
- Take notes on key points and info not the exact phrasing used
- Avoid direct quotes unless necessary
- Use a plagiarism checker if you're unsure

## Online plagiarism checker - Grammarly

(Sign up required, but free)

If in doubt, give the citation anyway



# **APA 7th Referencing**

#### <u>Involves two elements:</u>

#### In-text citations

Acknowledging the source(s) for specific information midsentence or at sentence end

- Author + year e.g., (Jenkins, 2020)
- Use "et al.," if 3+ authors
- Cite multiple sources by separating them with a semi-colon (Jenkins, 2020; DeLaune et al., 2007)

#### 2. Reference list

Providing a list of all sources used for the document

MUST include all in-text citations

According to DeLaune et al. (2007), [...]

"The nursing process is the specific problem-solving method used by you to arrive at the point at which decisions about patient care can be made" (DeLaune et al., 2020, p. 64).

DOI = Digital Object Identifier – Every DOI is unique and linked to one article only
- Not all articles online have a DOI though

# Common APA Referencing Examples

#### Webpages

Author [Last name], A. A. [Initials] or Corporate Author [Full name of Company]. (YEAR, MONTH DAY [if available]). [*Title of webpage in italics*]. http://xxxxxx [URL of webpage as hyperlink]

Include a retrieval date only if source is likely to change (e.g., government guidelines)

Tertiary Education Quality and Standards Agency. (n.d.). *What is academic integrity?* Retrieved November 22, 2021 from <a href="https://www.teqsa.gov.au/what-academic-integrity">https://www.teqsa.gov.au/what-academic-integrity</a>

## **Reference Lists**

#### Included at the end of an assessment

- "References" as a heading at the top
- Hanging indent
- ALL sources cited in-text must be included
- Sorted alphabetically by 1<sup>st</sup> author's last name/company name
  - If the same author(s) have multiple publications in the list, earliest goes first
  - If same author(s) and same year, the earliest cited in your assignment goes first with a letter after the year (2014a), (2014b), and so on
- Use (n.d.) if no publication year can be found
- DOI's and URL's as hyperlinks
  - https://doi.org/xx.xxxx/xxxxxxxx (Insert DOI)

# VERIFYING INFORMATION FROM AN ARTICLE

# **Verifying Article Info**

#### Info used to cite the source

- Search for the DOI or use the URL
- If no DOI/URL, search the name (and edition) and author (if available)
- For books ISBN or ISSN can be used

MANAGER (e.g., Zotero, EndNote) OR ONLINE
CITATION GENERATOR

#### Info given within the source

- Find the source
- Follow page numbers if given
- Look at keywords in the info you want to find
  - "The nursing process is the specific problem-solving method used by you to arrive at the point at which decisions about patient care can be made" (DeLaune et al., 2020, p. 64).
- Use the 'Find' function on web browsers in the document
  - Ctrl + F usually (Windows)
- If all else fails, try searching the key words in a search engine

#### Abstract

**Objective:** The 2010 Survey of High Impact Psychosis (SHIP) is Australia's second national psychosis survey. This paper provides an overview of its findings, including comparisons with the first psychosis survey and general population data.

**Methods:** The survey covered 1.5 million people aged 18-64 years, approximately 10% of Australians in this age group. A two-phase design was used. In phase 1, screening for psychosis took place in public mental health services and non-government organizations supporting people with mental illness. In phase 2, 1825 of those screen-positive for psychosis were randomly selected and interviewed. Data collected included symptomatology, substance use, functioning, service utilization, medication use, education, employment, housing, and physical health including fasting blood samples.

**Results:** The estimated 1-month treated prevalence of psychotic disorders in public treatment services was 3.1 people per 1000 population; the 12-month treated prevalence was 4.5 people per 1000. The majority (63.0%) of participants met ICD-10 criteria for schizophrenia/schizoaffective disorder. One-half (49.5%) reported attempting suicide in their lifetime and two-thirds (63.2%) were rated as impaired in their ability to socialize. Over half (54.8%) had metabolic syndrome. The proportion currently smoking was 66.1%. Educational achievement was low. Only 21.5% were
